STEP 1)

Update your Google My Business Listing to have your COVID Information Readily Available

Sign In and navigate to the home screen (HOME in lefthand menu)

You will see the graphic to the left with these options:

- Update Service Availability
- Update Business Hours
- Post Your COVID-19 update

STEP 2)

Add a **COVID Vaccination page** to your website. This page should include information about the vaccine, how your pharmacy plans to handle the rollout and CDC guidelines, and **clear** directions on how to schedule a **1st & 2nd dose** with your pharmacy.

We would also recommend utilizing a combination of **online forms and scheduling** that sync with your Google or other calendar to help you keep track of your vaccine doses and physical traffic to your pharmacy. This can be implemented relatively quickly on **Squarespace**, **WordPress, and Wix sites.** If you are unsure of how to do this, let us know.

STEP 3)

Update your social media profile. Make sure to utilize Facebook's COVID Update feature and ability to "pin" your post to the top of your feed.



Create an announcement post with **clear details** with information highlighting:

WHEN: dates & times WHERE: to receive more information or schedule their vaccination with you.

Then, after you have posted your update, click on the three dots in the **upper right corner**.

Select Mark as COVID-19 Update and alternately "pin to Top of Page".
